CITY OF VENICE, FLORIDA CITY COUNCIL ORDER NO. 20-55SP FOR WAIVER

AN ORDER OF THE VENICE CITY COUNCIL APPROVING A WAIVER OF THE SIDWALK REQUIREMENTS IN SECTION 86-520 OF THE CITY OF VENICE CODE OF ORDINANCES FOR KILPATRICK ROAD FOR THE **ISLAND VILLAGE MONTESSORI CHARTER SCHOOL** LOCATED AT 2001 PINEBROOK ROAD; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Island Village Montessori Charter School, through its agent, Gregg Fisher, Fisher Engineering, has submitted a waiver request from the sidewalk requirements in section 86-520 of the City of Venice Code of Ordinances for Kilpatrick Road for Island Village Montessori Charter School, located at 2001 Pinebrook Road, Parcel Identification No. 0386-09-0002 (further described in Exhibit A); and,

WHEREAS, the applicant submitted the waiver request in conjunction with Site and Development Plan Petition No. 20-55SP; and,

WHEREAS, the Planning Commission held a noticed public hearing on April 20, 2021, during which the Planning Commission received the staff report and testimony provided by staff, the applicant, and interested parties, and voted to approve Site and Development Plan Petition No. 20-55SP and recommend approval to City Council of the request for a waiver from the sidewalk requirements in section 86-520 for Kilpatrick Road; and,

WHEREAS, on June 8, 2021, City Council held a noticed public hearing during which the City Council received the staff report and testimony provided by staff, the applicant, and interested parties; and,

WHEREAS, the City Council finds that there is competent substantial evidence that the waiver request demonstrates compliance with the applicable standards and criteria of the City Land Development Code and is consistent with the Comprehensive Plan; and,

WHEREAS, the City Council voted to approve the waiver request.

NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL, THAT:

Section 1. The above whereas clauses are ratified and confirmed as true and correct.

<u>Section 2</u>. The waiver of sidewalk requirements for Kilpatrick Road for Island Village Montessori Charter School, as described above, is hereby approved.

<u>Section 3.</u> This Order shall become effective immediately upon adoption by City Council. The City Council or any aggrieved person may have recourse to such remedies in law and equity as may be necessary to ensure compliance with the provisions hereof.
