Schedule the public hearings before City Council and provide our office with the legal advertisement when you send it to the Gondolier in order for us to prepare the notification sign and post on the property 15 days prior, per public notice requirements. Three of the properties in this amendment require the State's expedited review process which includes a transmittal hearing (1st reading) before City Council, then transmittal to the Florida State Department of Economic Opportunity (DEO). Once is it reviewed by the DEO and other State agencies, it will be returned for a City Council adoption hearing (2nd reading). Although the other three properties in this amendment will require the State's small-scale review process which includes two readings of the ordinance before City Council, we request they be held until the other petitions are ready for adoption, so they move forward through City Council hearings together as one group. The adopted amendment will then be transmitted to the DEO for their records.
