ORDINANCE NO. 2021-34

AN ORDINANCE OF THE CITY OF VENICE, FLORIDA, AMENDING CHAPTER 74, UTILITIES, ARTICLE I, IN GENERAL, SECTION 74-11, WATER, SEWER AND RECLAIMED WATER RATES, BY MODIFYING UTILITY WHOLESALE SANITARY WASTEWATER MONTHLY CHARGES; PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is well known that the water and wastewater infrastructure of the United States requires major investment to sustain the economic vitality and lifestyles to which citizens have become accustomed; and

WHEREAS, analysis has determined the current schedule of rates, fees, and charges should be modified to more accurately recover the costs associated with the provision of wholesale sanitary wastewater services; and

WHEREAS, city council finds the proposed schedule of fees and charges is reasonable and fair to fund the utilities department's costs involved in the provision of wholesale sanitary wastewater services; and

WHEREAS, analysis has determined a more fair and equitable distribution of rates, fees, and charges amongst the wholesale sanitary customer category.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA, as follows:

SECTION 1. The whereas clauses above are ratified and confirmed as true and correct.

SECTION 2. Chapter 74, Utilities, Article I, In General, Section 74-11, Water, sewer and reclaimed water rates, is amended as follows:

ARTICLE I. IN GENERAL

Sec. 74-11. Water, sewer, and reclaimed water rates.

(a) *Schedule of charges*. There is hereby established the following schedule of charges for the use, or reasonable availability for use, of the services of the city water and wastewater system. The monthly readiness for service charge is for the reasonable availability for the use of the system and shall be due regardless of whether the system is actually used and/or property is occupied.

(1) Water Service. No change.

The City of Venice Code of Ordinances is amended as follows with strike through text identifying deletions and <u>underlined text</u> indicating additional language.

(2) Sewer service.

- a. Monthly readiness for service charge. No change.
- b. Monthly consumption charge (dollar per 1,000 gallons), all users. No change.

c. Wholesale sanitary monthly fixed charge.
