- 305.3.2 All portions, additions or sections of a roof including, but not limited to, the fascia, eave, soffit, sheathing, rafter, vent screening, gutter, down spout, roof jack, lead or metal flashing, shall be complete with all trim strips, molding, brackets, brace and supports in accordance with common building practices. No item shall display signs of deterioration, abuse or improper installation that could be construed to affect the purpose of that item or cause damage to the immediate area or roof structure, that could allow dampness or admit rain to the interior of that building.

- **4.** You are hereby notified that you must clear the violation by obtaining all required permits or hiring a licensed contractor to obtain all required permits to repair the roof to prevent further damage to the dwelling.
