Mr. Lavallee discussed health and safety protocols and city hall health measures to contain spread of the COVID-19 virus, including masks with public interaction, sanitation stations, fogging of building, TEAMS meetings, remote working when possible, and suspending special event permits for public property.

Discussion took place regarding metrics being used in decision making for events resuming and notification to city council.

Mark Andes, 416 Golden Beach Boulevard, spoke regarding ordinances, against meetings in the shade, cancellation of meetings, constituent participation, business owner support, lock downs, restrictions, and business opportunities, disagreement with sidewalk change and city manager making emergency decisions.

David Ortins, 535 Serata Street, spoke regarding Venezia Park budget, improvements that are being considered, and recommended against approving the proposal for asphalt walkways around the park, suggested limiting walkways, history of the park, and the need for more shade.

Jeffrey Boone, 520 Venezia Parkway, spoke to Venezia Park being the largest park in the city, feels the park is a disgrace, and noted the playground equipment, dog usage, the need for grass, and recommended making the park more usable by residents.
