Mayor Pachota called the meeting to order at 9:00 a.m.

Finance Director Linda Senne: Quarterly Financial Update (10 min)

Finance Director Senne provided a presentation to include general fund revenues and general fund expenditures, and reviewed fund and reserve balances.

Discussion took place regarding the budget overage due to utilizing a lobbyist, the increased funds it resulted in, and the increased interest earned on investments.

C. COUNCIL ACTION/DISCUSSION

Planning and Zoning Director Roger Clark: Potential Rezoning of the Venice Bay Mobile Home Park Area

Planning and Zoning Director Clark provided a presentation regarding potential rezoning of the Venice Bay Mobile Home Park to allow for additional types of housing, current permitted types, maintaining affordability and density, importance of not taking options away from residents, and responded to Council questions regarding whether other manufactured home communities could benefit from the same rezone and stated the focus has been on this park due to its location on coastal high hazard area, but other parks could be possible.

Discussion took place regarding current zoning and code, having more resilient options, architectural requirements, and resident interaction and feedback.

City Attorney Fernandez responded to a Council question regarding combining lots, stating that would be a private process that does not involve the City.

Planning and Zoning Director Clark responded to a Council question about permitting site built homes and elevating structures, stating the

City cannot violate the Comprehensive Plan and must maintain affordability, lot size requirements will not be increased, and lots are already platted.

Planning and Zoning Director Clark responded to a question regarding what the downside would be, and noted there was not any for the City, each condo association would direct their own requirements, current lot sizes would remain the same, and density must be maintained.

City Attorney Fernandez responded there could be a maximum lot size regulated.

A motion was made by Mr. Howard, seconded by Mr. Engelke, to approve the initial project concept and authorize staff to proceed with the City-initiated rezone work.

Discussion took place regarding the commendability of ideas, concerns about elevating homes, and need for further details.

Review of Venice Charter Article III, Legislative, Section 3.02(b)
Vice-Mayor (City Attorney Fernandez)

City Attorney Fernandez stated the Vice Mayor appointment is now a two year term based on language in the City's Charter which indicates the selection of Vice Mayor be held following the certification of election results. She shared the language from other cities, the option for doing an annual election of Vice Mayor which would involve a choice of having a special election or deferring to 2026 election.

A motion was made by Mrs. Frank, seconded by Vice Mayor Boldt, to direct the appropriate charter officer to propose a charter amendment that would provide for an annual election of the Vice Mayor for the next regularly scheduled election in 2026.

Discussion took place regarding best practices in the area, giving Council the option of appointment every year, any other issues that should be addressed in the next election, a charter review board review, clarifying this would not be a special election, would still go through the ordinance process, and the former charter review committee was sunsetted in 2022.

City Attorney Fernandez commented the previous charter review committee did not recommend the regular convening of a charter review committee.
