Mr. Veneziano spoke on the county providing maintenance, FDOT funding system maintenance, staff expertise, automated signalization, and the Regional Traffic Management Center (RTMC).

Discussion ensued regarding control of traffic signals, population formula, maintenance clause, level of inspections, county agreement with FDOT, RTMC, and requesting copies of maintenance logs from the county.

ORDINANCES - FIRST READING

Mayor Holic announced this is a continuation of a quasi-judicial procedure.

Mayor Holic reopened the public hearing for the purpose of hearing from both parties regarding council's request to resolve compatibility issues.

Mr. Persson questioned council on conflicts of interest and ex-parte communication since the last hearing. There were no conflicts of interest. Mr. McKeon and Mr. Daniels noted site visits. Mr. Persson requested all communication be sent to the city clerk.

Ms. Stelzer stated emails were received from Ed Martin, Jeff Boone, Dan Lobeck, and Joyce Adams. Ms. Stelzer noted the seven emails will be added to the agenda packet for final reading as new written correspondence.

Jeff Boone, representative of property owner, being duly sworn, spoke regarding list of issues received from the affected party, meeting held with affected party, and not reaching agreement.

Dan Lobeck, representative of affected parties, being duly sworn, spoke on meeting between parties, proposed stipulations and tiers, and lack of agreement reached during negotiations.

Mr. Boone spoke on Dr. Robert Burrus' involvement with prior developments, joint planning agreement (JPA), and comprehensive plan amendment, October 21, 2015 neighborhood meeting, April planning commission meeting, lack of attempts for parties to meet, concessions, counter proposal, and testimony from the affected parties expert. Mr. Lobeck objected to Mr. Boone citing the expert's testimony. Mr. Boone continued to discuss proposed stipulations.

Mr. Fraize left the dais at 10:46 a.m. and meeting went into recess until 10:53 a.m.

Mr. Boone spoke on two additional concessions being offered.

Discussion followed on providing clarity on the combined stipulations and amending the motion.

Mr. Lobeck suggested a two week continuance for wording to be revised, and spoke on settling negotiations, accepting fencing and vegetative buffer stipulations, and improving language regarding height measures on the southern boundary of the property. Mr. Boone objected to a continuance.

Discussion continued on having parties negotiate and recessing the public hearing until the afternoon, parties agreeing to height and density restrictions, providing council with an updated version of agreed stipulations, and defining rental units.

Mayor Holic recessed the public hearing until 11:55 a.m.

A motion was made by Council Member McKeon, seconded by Council Member Cautero, for the city manager to provide a cost and labor estimate for the utilities department to develop a presentation. The motion carried unanimously by voice vote.

James Courtright: Request Council Approval for the Installation of an EZ Launch Kayak Launch at Venice Myakka Park (5 min.)

Mr. Courtright provided a presentation on the Venice Myakka River Park and spoke regarding the kayak launch, assistance entering and exiting the kayak, EZ Launch solution, and unit manufacturer, cost, and funding.

A motion was made by Council Member Cautero, seconded by Council Member Fraize, that Item No. 16-2314 be approved.

Discussion followed on project funding and maintenance, handicap parking spots, and parking on Laurel Road.

The motion carried unanimously by voice vote.

16-2315 David Barth, Toole Design Group: Parks Master Plan Final Draft and Request Council Approval to Update Based on Board Recomendations and Citizen Input (20 min.)

Mr. Veneziano provided history on the parks master plan.

David Barth, Toole Design Group, provided a presentation on the parks master plan to include purpose, project schedule, standards, level of service (LOS), the public realm, placemaking, summary of needs and priorities, long range vision framework, maintaining the integrity of the Nolen Plan, recommendations, improving beach access, improving existing parks, protecting and enhancing natural areas and habitat, expanding the trails and bikeway systems, yearly priorities, cost and funding sources, and comprehensive plan recommendations.

Discussion followed on public access parks, community and neighborhood based activities, Ajax property, Venetian Golf and River Club amenities, multi-purpose community parks, maintenance of parks, city expenditures, and LOS on public and private parks.

Mr. Veneziano spoke on recommended amenities and budget expenses for city parks.

Discussion continued on scheduling a workshop, LOS measurement, adequacy of outreach sampling, repairs and maintenance, suggestion for county ownership of sports complex, cost and funding estimates, Ajax property purchase, and design standards.

Larry Humes, 240 Santa Maria Street, spoke on issues with pocket parks, Nolen Plan purpose and design, and agreement to re-establish original outlook.

There was council consensus for Ms. Stelzer to schedule a workshop with Mr. Barth, Council Members, and chairs or representatives of the Parks and Recreation Advisory Board, Environmental Advisory Board and Planning Commission.

Recess was taken from 3:12 p.m. until 3:20 p.m.

Alan Bullock, Administrative Services Director and Kathleen Meola, Consultant, Ascension Benefits and Insurance Solutions: Healthcare Costs for Employees, Retirees and Dependents (15 min.)

Mr. Bullock spoke on city's healthcare benefits to include changes, payment of claims, discounts, participants, total healthcare costs for 2015, employee and retiree contributions, subsidies, Medicare eligibility plan, and wellness program.

Ms. Meola spoke regarding the city's health plan ten year performance study to include claim costs, net cost to the city, 2008 Blue Cross contract, discounts, trend analysis, and costs per participant per month.

Discussion followed on reserve balance, pharmaceutical costs, health care cost payment for 2015, and 501 fund.

Ms. Senne responded to council questions regarding reserve balance, 501 and general fund, and employee cap on reserves.

Ms. Meola spoke on stop loss, premiums, city's performance over the last ten years, city's experience versus national trend, plan design changes, and implemented changes effective January 1, 2017.

Discussion ensued on tobacco users, premium credits and incentives, employee nicotine testing, compliance rules, and Health Insurance Portability and Accountability Act (HIPAA) non discrimination rules.

Discussion followed on e-cigarets, 2017 health care cost increases, full funded rate, actuary report, future premium costs, consumer driven health plan, health savings account option, smoking cessation program, and tobacco user premiums.

Request Sponsorship for Chalk Festival 2016 in the Amount of \$10,000, Which is \$5,000 Above the Economic Development Advisory Board's Recommendation

Denise Kowal spoke on her sponsorship request for the Chalk Festival to include amount of artists coming to the event, challenges, economic impact, entrance fees, and event popularity and budget.

Mike Pachota, owner of Sharky's Restaurant, spoke on his support of the chalk festival.

A motion was made by Council Member Gates, seconded by Council Member Daniels, to approve Item No. 16-2317.

Discussion followed on event funding, city's profit, prior sponsorships, tax increase, amateurs gaining advice from professional artists, economic impact on the community, tightening standards and guidelines on city events, community charitable causes, and promoting tourism.

The motion failed by voice vote 2-5 with Mayor Holic and Ms. Gates in favor.

A motion was made by Council Member McKeon, seconded by Council Member Daniels, to approve sponsorship in the amount of \$5,000 for the Chalk Festival as recommended by the the Economic Development Advisory Board.

Discussion continued on the requested amount to be approved.

The motion carried by voice vote 6-1 with Ms. Anderson opposed.

16-2319 Determination on Continuing the Use of the Showmobile

Discussion followed on the showmobile to include rental costs, revenue. depreciation schedule, trade in value, setup time, operation costs. community asset, replacement value, life expectancy, budgeting yearly depreciation, functionality and current condition, turnover time, notifying all event owners to seek alternative options, history, setup and takedown fees, renting showmobile from county, and storage at an airport t-hangar.

Discussion ensued on ranking capital expenses, affected events, renting county showmobile for the first quarter, obtaining data from neighboring cities and Sarasota County on the availability of their showmobile, safety concerns, and termination date for using current showmobile.

There was council consensus for staff to collect more data and contact neighboring cities and Sarasota County on the availability of their showmobile and report back to council.

Request that the City Manager Research the Necessary Requirements and Protocol for the Venice Police to Potentially Provide Traffic Enforcement on Private Roads (Cautero)

Discussion followed on the request for more traffic enforcement within Venetian Golf and River Club and Bay Indies communities, issues with people speeding and running stop signs, required stipulations, approval for the city manager to research information and report back to council, public safety bond, police LOS, providing deterrent, proper signage, stipulations on golf carts, residents paying for traffic services, and Mr. Cautero assisting the city manager if motion passes.

Mr. Lavallee noted he has already conducted some research and will obtain legal guidance on traffic management.

A motion was made by Council Member Cautero, seconded by Council Member Fraize, to approve Item No. 16-2320. The motion carried unanimously by voice vote.

Discussion ensued on taxing and potential need for more law enforcement resources.
