Erick van Malssen, Stantec Consulting Services: Proposed Fire and Police Impact Fees (10 min.)

Mr. van Malssen spoke to preliminary results of the law enforcement and fire impact fee study to include impact fee background, and cost basis for law enforcement impact fee, and responded to council questions regarding calculation methods of other jurisdictions.

Mike Burton, Stantec Director for Operations, responded to council questions regarding new development construction and individual homes developed.

Discussion took place regarding expansion of the police department facility.

Mr Lavallee spoke to prior use of the facility as a holding cell and new facility functionality.

Mr. van Malssen continued his presentation on cost basis for fire impact

fees, impact fee calculations and fee survey results.

Discussion took place regarding consideration of services provided outside of the city limits.

Mr. Persson addressed rezone ordinances in regards to provisions that require contributions and statutes that allow the city to charge impact fees for growth.

Mr. van Malssen spoke to recommendations to city council and next steps to include implementation process.

Discussion ensued regarding new construction that is already underway, current collections regarding impact fees and usage, line items to show where funds are being allotted, impact fees collected by the county, communities utilizing full cost recovery, process for receipt of monies, investigating fees the city may be entitled to and administration of fee collection, and cost effectiveness of collecting fees that are currently collected by the county.

Jeff Boone, Boone Law Firm, spoke to understanding that impact fees are for capital costs, expressed concern with consultants lack of information and proper use of impact fees and responded to council questions regarding representation.

A motion was made by Council Member Daniels, seconded by Council Member Anderson, to direct staff to draft a fire impact fee ordinance on all new housing with a plan to be fully implemented by January 2018.

Discussion took place regarding benefits to the city, possible unforeseen circumstances, and for staff to include current impact fees for a \$350,000 house.

The motion carried by voice vote unanimously.

A motion was made by Council Member Daniels, seconded by Council Member Fraize, to direct staff to draft a police impact fee ordinance on all new housing with a plan to be fully implemented by January 2018.

Discussion took place regarding the timeline needed to ensure proper notice, determining the procedure for the city to maintain, and receiving timeline input from the city manager at the next meeting.

The motion carried by voice vote unanimously.

Mr. Pickett reviewed the petition to include property information, existing and future land use designation, concurrently processed land development petitions, aerial photograph of property, summary of proposed comprehensive plan amendments, existing and proposed future land use maps, existing and proposed northern gateway corridor maps, planning analysis, comparison of existing and proposed designations, evaluation of the impact on the comprehensive plan and the Northern Gateway Corridor, compliance with the land development code, comprehensive plan, and other relevant city ordinances, resolutions or agreements, effect on the financial feasibility of the comprehensive plan, consistency with the applicable requirements of Florida Statutes Chapter 163, and staff summary findings of fact.

In response to council questions, Mr. Pickett spoke to the submerged land, removal of height restrictions, height regulations, developer behind the LLC., previous projects on the Intracoastal Waterway, comprehensive plan amendment from water to commercial, existing property use with a commercial designation, possible commercial usages, planning commission discussion, potential action on the northern parcel, access to the marine facility by police, and maximum building height.

17-2858 Support Services Lieutenant Eric Hill, Venice Police Department: Fishing Pier Activity Update (10 min.)

Mr. McKeon left the dais at 1:48 p.m. and returned at 1:49 p.m.

Lt. Hill provided an update on the pier to include initial incident, discussion with witnesses, not being able to enforce the use of profanity, and observation by site team and trespass warnings received for violations, and responded to council questions regarding holes drilled into the wood of the pier, observation of shark fishermen, and future use of drone technology.

Discussion took place regarding placing shark fishing limitations, cause of

damage to netting, and discussing safety concerns with shark fishing near beaches on a future agenda.

<u>17-2859</u> Development Services Director Jeff Shrum: Code Enforcement Activities Update (10 min.)

Mr. Shrum provided an update to include offer on code enforcement supervisor position, SeeClickFix, and tracking software for resort dwellings, and responded to council questions regarding enforcement of business tax receipts, monitoring of SeeClickFix, code enforcement officers being proactive, and seven day coverage.

17-2860 Development Services Director Jeff Shrum and Assistant City Attorney Kelly Fernandez: Requesting Council Direction on Medical Marijuana Dispensaries (10 min.)

Mr. Shrum spoke to planning commission request for feed back from council.

Ms. Fernandez spoke to law passed giving the option to ban all dispensaries in the city or allow them with no stricter regulations than a pharmacy and existing Sarasota County regulations.

Discussion took place regarding restrictions on drive through windows, state law prohibiting smoking and not vaping, county regulations, and concern with enforcement.

Ms. Fernandez clarified Sarasota County's current regulation and stated if prohibited now, council may allow in the future.

A motion was made by Council Member Daniels, seconded by Council Member Fraize, to prohibit medical marijuana dispensaries in the city.

Discussion took place regarding the need for medical marijuana for serious illnesses.

Mr. Lavallee spoke to zoning issues regarding dispensaries.

Discussion continued on the need for more information and determining which municipalities have voted to ban medical marijuana.

A motion was made by Council Member Cautero, seconded by Council Member Anderson, to postpone the motion until September 26, 2017 city council meeting to allow for more information to be provided. The motion carried by voice vote with Mr. Daniels opposed.

Review Concept of Sarasota County's Life Sustaining Ordinance (Lavallee)

Mr. Lavallee spoke to the life sustaining ordinance drafted by the county regarding homelessness and the request for council input and responded to council questions regarding existence of a shelter, and the requirement to offer shelter to the homeless.

Ms. Fernandez spoke to beds at the Salvation Army in the City of Sarasota that are unrestricted that officers would be able to offer prior to issuing a

citation.

Discussion continued on enforcement and transport of the homeless to the shelter.
