Ms. Taylor read the ordinance by title only.

Mayor Holic opened the public hearing.

No written communication was received and no one signed up to speak.

Erick van Malssen, Manager, Stantec Consulting, provided a presentation to include impact fee background and current impact fees for the city.

Discussion followed regarding collection of transportation/mobility fees by Sarasota County, general government impact fees, Legacy Park, impact fee expenditures, and project funding contributions by the county.

Mr. van Malssen spoke on police and fire impact fees to include cost basis, calculations, surveys, full cost recovery, and recommendations and next steps.

Discussion followed on existing equivalent dwelling units (EDU), retail/commercial unit impact fees, occupancy differential, multipliers, cost recovery, and using impact fees for funding personnel.

Chris Roe, Attorney with Bryant, Miller, and Olive, provided clarification regarding growth expansion and impact fees.

Discussion continued on full cost recovery, mitigation fees, revenues, capital expansion, being consistent with the county's methodology, replacement costs, legal challenges, Sarasota County's impact fee ordinance, methodology meeting case law requirements, revenue projections for the finance and building departments, and application of impact fees for new building permits after March 18, 2018.

Chief Carvey commented on the fire assessment fee study, the fire department's ten year capital improvement plan, and utilizing impact fees.

Captain Rose commented on the police department's five year projection plan to include adding personnel, resources, and fleet vehicles.

Discussion ensued on the collection and use of impact fees, the fire department's ten year capital program, ladder trucks, and mutual aid from surrounding cities.

Mayor Holic closed the public hearing.

A motion was made by Council Member Daniels, seconded by Vice Mayor Cautero, that Ordinance No. 2017-34 be approved on first reading and scheduled for final reading.

Discussion took place on building permits and impact fees for new homes, general operating budget, tax savings, special mitigation fees, expansion of the public safety building, one-cent sales tax, legal basis to use impact fees, time frame to spend impact fee revenues, and building a fourth fire station.

Chief Carvey commented on building a fourth station and relocation of fire station no. 2.

Discussion followed regarding relocation of fire station no. 2.

The motion carried by the following vote:

Mayor Holic announced this is a quasi-judicial hearing and opened the public hearing.

Ms. Fernandez questioned council on ex-parte communications and conflicts of interest.

Mr. McKeon and Mr. Daniels disclosed walking by the property. There were no conflicts of interest.

Ms. Stelzer noted written communication is in the record and included in the agenda packet.

Ms. Fernandez provided a brief introduction and explained establishing aggrieved party status.

Ms. Anderson noted speaking with neighborhood residents prior to knowing about the appeal and returning a telephone message. Ms. Anderson confirmed she can be fair and unbiased and base her decision on the evidence presented today.

Margaret Schreiber, 429 Beach Park Boulevard, being duly sworn, spoke regarding appeal, Beach Park subdivision and corner lots, properties identified with front yard pool variances, concern with pool design and features, public hearing notification, meeting with applicants Ron and Lise Juneman, and withdrawing appeal.

Ms. Schreiber withdrew the appeal.

Discussion followed regarding neighborhood residents and the appeal.

Ms. Fernandez explained Ms. Schreiber was the only individual who timely appealed and the planning commission's order will be the final order in this matter.

Discussion followed regarding Ms. Anderson's disclosure, site and development plan, variances, and moratorium.

Mr. Shrum, being duly sworn, commented on reviewing plan changes and

obtaining a formal application for development approval.

Discussion ensued on variance approval and plan changes.

Ron Juneman, 422 Beach Park Boulevard, being duly sworn, spoke regarding contact with neighbors and reaching a resolution on the proposed variance.

Lise Juneman, 422 Beach Park Boulevard, being duly sworn, commented on permit, signed agreement with approved developer, application, and changes.

Ms. Fernandez noted council does not need to take any action.

Discussion followed on establishing end dates for all stakeholder groups.

Consideration and Action on Appeal by McLeod Recycling to Planning

Commission's Denial of Petition No. 17-03SP, 700 Gene Green Rd, 700 Gene Green, LLC. (Quasi-Judicial)

Mayor Holic announced this is a quasi-judicial procedure and opened the public hearing.

Ms. Fernandez questioned council on ex-parte communications and conflicts of interest. Mr. McKeon noted hearing presentation at the planning commission meeting and speaking with the applicant's attorney, Vice Mayor Cautero noted living in the Venetian Golf and River Club (VG&RC), Mayor Holic stated he received a legal document from McLeod Recycling, Mr. Daniels noted living in Willow Chase, and Mr. Fraize disclosed riding his bicycle around the area and speaking to one of the Crush-It, Inc. owners to get a better understanding of their operations. Mr. McKeon, Vice Mayor Cautero, Mayor Holic, Mr. Daniels, and Mr. Fraize confirmed they can remain fair and unbiased and base their decision on the evidence presented today.

Ms. Stelzer noted written communications were included in the agenda packet, two emails were received yesterday, and one email was received this afternoon from the VG&RC Community Association that will be added to the packet.

Ms. Fernandez provided a brief introduction to include affected party request was rescinded.

Mr. Clark, being duly sworn, provided a presentation on the site and development plan petition to include background information, aerial photograph, site plan and photographs, surrounding property information, future land use map (FLUM), existing zoning map, comprehensive plan consistency, rezoning ordinance and pre-annexation agreements, compatibility Policy 8.2 Mitigation Techniques, planned industrial development (PID) and land development code (LDC), consistency, concurrency, and summary findings.

Mr. Clark responded to council questions regarding hours of operations, consistency with the comprehensive plan, water reservoir, potable water, environmental impact study, Sarasota County's long term plan, compliance issues, property boundaries, mitigation techniques and enforcement, and emission control measures.

Discussion followed regarding facility inspection by Sarasota County, compliance with environmental ordinances, obtaining information from the county, reservoir, complaints and violations, paved area, Laurel Oaks Road, property acreage, size of lake, and site visit and investigation.

Darenda Marvin, certified land planner with Grimes, Goebel, Grimes, Hawkins, Gladfelter, and Galvano, P.L., being duly sworn, provided a presentation and spoke on McLeod Recycling to include history, June 2004 pre-annexation agreement, February 2009 rezone ordinance, 2017 site and development application, standards of review, property owned by 700 Gene Green LLC, potable water, compliance issues, mobile crusher, and request for site and development approval.

Ms. Marvin responded to council questions regarding length of time McLeod Recycling has been in business, buffering adequacy, and noise test.

Derin Parks, Attorney with Grimes, Goebel, Grimes, Hawkins, Gladfelter, and Galvano, P.L., being duly sworn, spoke on the site preparation permit.

Discussion continued regarding code violations, development regulations, neighborhood meeting, focusing on land development, agenda materials, violations issued, temporary use application, and the planning commission's decision.

Ms. Fernandez stated code enforcement is relevant to the history of the application, and provided clarification on the basis to determine approval or denial of the site and development plan, and notice of violation issued.

Discussion took place regarding imposing fines for failure to comply, reservoir, county's input on environmental concerns and continuing item until information is received from the county, environmental impacts, compatibility, and landscape plan.

Recess was taken from 2:40 p.m. until 2:50 p.m.

Mr. McKeon returned to the dais at 2:51 p.m.

Discussion took place regarding environmental concerns and crushing demonstration.

Ms. Fernandez clarified character is not a basis for determination of the application.

Mr. Shrum, being duly sworn, spoke to crush testing and temporary use permit application.

Discussion followed regarding compatibility, environmental and noise impacts, and the appellant reaching an agreement with neighborhood residents.

James McLeod, appellant, being duly sworn, spoke regarding contact with the homeowner's association president, the distance between his office and crushing operation, noises, environmental and air quality permits, Sarasota County's report, environmental hazard, dust, Southwest Florida Water Management District (SWFWMD), Florida Department of Environmental Protection (FDEP) permit, communication with city staff, and permit application.

Ms. Marvin commented on the permit issued December 2016 to expand the water storage facility.

Mr. McLeod spoke to the Dona Bay project.

Discussion took place regarding Crush-It, Inc. testing and operations, noise, buffering, berm, parties reaching an agreement, and reservoir.

Mr. Clinch, being duly sworn, provided an update on the Dona Bay project.

Discussion followed on recycling water, surface water, dust, issuing a temporary use permit for demonstration purposes, noise test for buffering, machine backup alarms, truck exhaust breaks, and scheduling demonstration.

Jerry Jasper, 130 Burano Court, on behalf of the VG&RC Community Association, being duly sworn, spoke regarding affected party status waiver, opportunity to meet with appellant and reach an agreement, and Section 86-132 (c)(7) Planned Industrial Development (PID) District and Policy 16.24 Gene Green Sector Uses of the comprehensive plan.

John Moeckel, 185 Treviso Court, on behalf of the VG&RC Community Association, being duly sworn, spoke regarding proposed arrangement with the appellant, crushing demonstration, planning commission meeting, lawsuit, meeting with Mr. McLeod, proposed operations, and mitigating impacts.

Carol Barbieri, 230 Padova Way, making statement on behalf of the VG&RC Community Association, being duly sworn, commented on 700 Gene Green, LLC meeting with the association to reach an agreement, the association working with companies operating in the Gene Green Sector, and the association's agreement with Crush-It, Inc. and support of their site and development plan.

David Lusty, 109 Asti Court, being duly sworn, noted his property is the most northern in the VG&RC and closest to the proposed plan, and spoke

to the conditions in the pre-annexation agreement, noise from Crush-It, Inc., and Mr. McLeod's operations.

Marshall Happer, 117 Martellago Drive, being duly sworn, spoke on the pre-annexation agreement and noted involvement with the stipulations in the agreement.

Mr. Shrum commented on the applicant's landscape plans, clarifying language in the pre-annexation agreement regarding recycled materials produced on site, zoning ordinance, special exception approval, allowable and existing uses identified in the pre-annexation agreement, concrete recycling, and staff's report.

Mr. Clark provided clarification on the southern boundary buffer, and noted project was reviewed by the county's arborist, and the county was notified of the petition.

Discussion followed regarding materials being crushed and generated on site, and language in the pre-annexation agreement.

Ms. Fernandez commented on the language in the pre-annexation agreement.

Discussion ensued on crushing demonstration and parties reaching an agreement, postponing item until the next council meeting, scheduling a special meeting, adding stipulations, and residents response for a timeline.

Mr. Jasper spoke to crushing operations, material handling, berm, operating conditions, demonstration, and timeline.

Discussion continued on crushing demonstration and timeline.

Discussion ensued on continuing hearing to December 12, 2017 council meeting, mitigating compatibility issues, and holding property owner accountable.

Mr. Parks spoke regarding berms, landscaping buffers, concrete operations, site and development plan, and evidence in the record.

Discussion followed on protecting compatibility, parties meeting and reaching an agreement, conditions of approval, city noise ordinance, postponing hearing to December 12, 2017 council meeting, Mr. McLeod's contact with the VG&RC community association president, resident feedback, permit process, test approval, competitors, code enforcement, stipulations, conducting demonstration and council postponing action until

conclusion of test, noise ordinance, berm, comprehensive plan Policy 8.2, and site and development plan.

Recess was taken from 4:58 p.m. until 5:05 p.m.

Mayor Holic closed the public hearing.

A motion was made by Council Member Gates, seconded by Council Member Daniels, to approve Petition No. 17-03SP site and development plan for the McLeod Recycling Yard with the following stipulations: 1) yearly neighborhood meeting to be held between January and April, 2) no operation during hours of darkness, 3) maintain an average berm of 15 to 20 feet between the crushing operation and southern boundary line, 4) Ordinance No. 2008-07 incorporates the pre-annexation agreement, 5) no Sunday hours, and 6) receipt of a notice of violation would cease operations until the violation is resolved.

Discussion followed regarding the average berm height, and removing the last stipulation on ceasing operations upon receipt of a notice of violation.

Mr. Daniels withdrew his second to the motion.

Discussion continued on the berm height and changing the wording on the third stipulation to include "perform noise level test on site for a period not to exceed 30 days and provide a berm if necessary up to a maximum of 30 feet".

Ms. Gates moved to approve the above stated changes and Mr. Daniels seconded the motion.

Discussion continued regarding adding a qualifier to what is "necessary" to meet the city's noise ordinance, and council having the stipulations in writing.

Ms. Gates withdrew her motion and Mr. Daniels withdrew his second.

Discussion ensued on addressing item at 10:00 a.m. tomorrow, Mr. McLeod communicating with VG&RC community association representative John Moeckel, stipulation language, and audience participation.

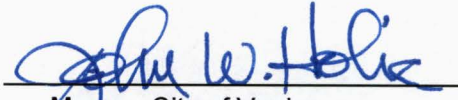
