Assistant City Attorney Kelly Fernandez and City Clerk Lori Stelzer: Refresher on Public Records and Sunshine Laws as Required by the Settlement Agreement in the Citizens for Sunshine and Anthony Lorenzo Litigation

Board members made introductions of new members David Stone and Claire Ellis.

Ms. Fernandez and Ms. Stelzer conducted annual sunshine law and public records law training to board members and went over a quiz.

Discussion took place regarding city considering making building more green, land use and building codes, review website for future meetings and sustainable community workshop on energy conservation.

17-2985 Bob Moroni, Public Works: Update on Venice's Curbside Recycling

Mr. Moroni spoke regarding the future of recycling, county extended contract, \$570,861 since 2010 made in selling recyclables, expand recycling for red bins, having discussions with Englewood, glass recyclables, single stream recycling, transfer station, tub grinder, North Port recycling every other week, dual stream recycling, providing an informational session to the public, how revenue money is being spent, sending a yearly calendar and answered board questions regarding electronic billing, larger recycling bins, solid waste audit and any issues with the county.

A motion was made by Mr. Courtney, seconded by Mr. Jones, that the board be opposed to the bill filed by State Senator Stuebe and recommend to city council that they take a position opposing the bill and write a letter to State Senator Stuebe regarding opposition of the bill.
