# **Engineering**

18-3608

Authorize the Mayor to Execute Municipal Separate Storm Sewer System (MS4) Permit Monitoring Interlocal Agreement Between Sarasota County and the City of Venice

A motion was made by Vice Mayor Daniels, seconded by Council Member Gates, to approve Item No. 18-3608.

Discussion followed regarding quality of water coming in versus going out of the city, water source, who pays for monitoring, county and city taxes, and viewing water quality report.

Ms. Weeden clarified request on obtaining NPDES (National Pollutant Discharge Elimination System) permit.

Mr. Clinch spoke to city's involvement with the program, Sarasota Water Atlas, county data, testing data for creeks and bays, and water monitoring.

Discussion followed regarding penalties, sewer connections, water quality monitoring agreement, partnership with Sarasota County to meet permit requirement, the county's action plan, water test result data, septic systems in the city, permit timeframe, requesting the state to reinstate House Bill 1738 on septic tank inspections, complying with state regulations, outfall monitoring, asking the county about projects initiated and completed to reduce septic pollution, and Sarasota Water Atlas data.

An amendment was made by Vice Mayor Daniels, seconded by Council Member Gates, that the county provide a written statement on projects started and completed, and the effect on water quality. The amendment carried unanimously by voice vote.

Discussion continued on county data and actions taken, length of agreement, obtaining a comprehensive project list from the county on water quality, city and county partnership, substance being monitored, preserving the environment, and the county's monitoring program.

The motion carried unanimously by voice vote.

### 18-3609

Authorize the Mayor to Execute Work Assignment 2019-02ENG with Stantec Consulting, Inc., in the Amount of \$48,875.00 for a Fiscal Year 2019 Stormwater Rate Study

Mayor Holic closed the public hearing.

Discussion followed regarding community team work, Curry Creek, and land presservation.

Discussion followed on downtown sidewalk bicycle traffic, Bicycle Pedestrian Program Coordinator Darlene Culpepper initiating a plan or map on bicycle routes, motorized bicycles, and modifying language in the ordinance to include prohibiting electric scooters, skateboards, roller blading, hover boards and moving instruments.

Discussion took place on audience participation time limits, council decisions impacting residents outside of city limits, giving priority to city residents, and extending time limit for residents with special needs.

Ms. Stelzer read the ordinance by title only.

No one signed up to speak.

A motion was made by Vice Mayor Daniels, seconded by Council Member Gates, that Ordinance No. 2018-39 be approved on first reading and scheduled for final reading.

Discussion followed regarding cost savings, generating revenue, educating citizens, enterprise fund, including an educational flyer with the utility bill, recycling surcharge, eliminating recycling, the county's recycling goal, using advisory boards to educate citizens, and charging different fees for different size cans.

An Ordinance of the City of Venice, Florida, Amending Chapter 62, Streets, Sidewalks and Other Public Places, Article V, Public Right-Of-Way and Public Property Permits, Section 62-121, Activities Requiring Permit; Section 62-123, Application; Section 62-124, Issuance, Conditions, Transfer; Section 62-126, Revocation; to Add Additional Regulations; Providing for Repeal of all Ordinances in Conflict Herewith; Providing for Severability and Providing for an Effective Date

Ms. Stelzer read the ordinance by title only.

No one signed up to speak.

A motion was made by Vice Mayor Daniels, seconded by Council Member Gates, that Ordinance No. 2018-40 be approved on first reading and scheduled for final reading.

Discussion took place regarding sidewalk lights, canopies, restaurant tables and chairs, and banners, code, providing information to Venice MainStreet CEO Erin Silk to relay to downtown businesses, downtown brick pavers, warmers, property owner consent to share sidewalk space, fee schedule to use public space, marking curb clearings, newspaper vending machines to include permit, regulating locations and Ms. Fernandez conducting further research, permit application fee, pressure washing requirement, city marking walkways, and modifying language in the ordinance.

An amendment was made by Council Member Fiedler, seconded by Vice Mayor Daniels, to amend the ordinance to include the city shall require pedestrian walkways and curbsides to be permanently marked by city staff.

Discussion continued on provide guidelines for markings, curb side clearing, staff deciding process for markings, brick pavers, delineating outside dining tables and chairs, code enforcement, and safety concerns.

The amendment carried by voice vote 5-2 with Ms. Gates and Mayor Holic opposed.

A motion was made by Council Member Gates, seconded by Vice Mayor Daniels, that Resolution No. 2018-35 be approved and adopted.

Discussion followed on having email as part of the utility signup with an opt out clause, code red and city newsletter automatic signup with an opt out clause, including instructions on how to opt out, electronic bill pay, and including a document to sign up for utilities in the closing packet on a home purchase.

## C. COUNCIL ACTION/DISCUSSION

18-3619 Discussion and Action on Painting of Street Storm Drains (Daniels)

Discussion took place on stormwater drain markings.

Ms. Weeden spoke to stormwater drain medallions, paintings, and markers.

Mr. Daniels spoke to his proposed motion.

A motion was made by Vice Mayor Daniels, seconded by Council Member Newsom, that in order to obtain a higher visibility of street stormwater drains that discharge into the gulf, staff will work with Venice MainStreet, Hands Along the Water and other volunteers to paint and label, both in English and Spanish, about the proper use. Painted areas will be evaluated for possible contamination by staff. The motion carried unanimously by voice vote.

18-3613 Consider Resolution to Oppose Offshore Drilling (Daniels)

Amendment to state constitution passed, therefore this item was not discussed.

<u>18-3614</u> Workforce/Affordable Housing (Newsom)

Mr. Newsom spoke regarding population growth, availability of goods and services, employee compensation, West Villages and availability of workforce/affordable housing, and action the city can take to provide more workforce housing.

Discussion followed on workforce housing in unincorporated areas, West Villages, Seaboard area, developer's application process, revenue from impact fees and taxes, 1992 William E. Sadowski Affordable Housing Act, private sector involvement, and the city taking action on available opportunities.

Don O'Connell, 433 Menendez Street, spoke to opportunity zones and designating the Seaboard area.

18-3615 Consider Proposed Ordinance for Skimmer Devices at Gas Pumps (Holic)

A motion was made by Vice Mayor Daniels, seconded by Council Member Newsom, for the city attorney to draft an ordinance on skimmer devices similar to City of Punta Gorda's adopted ordinance.

Discussion followed on state law, ordinance to address what the gas stations can do to avoid skimmer devices, state statute, law enforcement having set standards, citizen protection, and enforcement.

The motion carried unanimously by voice vote.

18-3616 Request all Advisory Boards to Report Semi-Annually (January and June) to City Council on Activities and Provide Directives on Board Actions (Holic)

Discussion took place on advisory boards reporting semi-annually to council, one report by board chair and the other by a board member, and

advisory board criteria.

A motion was made by Council Member Gates, seconded by Vice Mayor Daniels, to have Item No. 18-3616 as part of the strategic planning session.

Discussion ensued regarding adding a policy for boards to present to council twice a year, obtaining advisory board input, distinguishing think tank versus advisory boards, staff work assignments and support, and discussing topic during strategic planning.

The motion carried unanimously by voice vote.

18-3617 Discuss Protocol for Responding to Citizen Concerns and Inquiries During Audience Participation (Cautero)

Discussion took place on protocol for responding to citizen concerns during audience participation, implementing a tracking mechanism, and managing process and follow-ups.

Recess was taken from 3:21 p.m. until 3:28 p.m.

<u>18-3618</u> Red Tide (Holic)

Mayor Holic spoke regarding red tide to include nutrient pollution, septic systems, county's beach cleanup policy, lawn fertilization, and NutriSmart-B.

Mr. Lavallee commented on the city possibly purchasing a beach rake.

<u>18-3620</u> Discussion and Action on Island Traffic Count Data (Daniels)

Discussion took place on viewing traffic counter data from the three gateways and Mr. Lavallee providing the range of data collected.

There was consensus for the city manager to provide council and Venice MainStreet the traffic counter data from the three gateways.

18-3621 Discussion and Action on Management of Citizens Complaint Tracking Scorecard and Providing Monthly Reports to City Council (Daniels)

This item was discussed under Item No. 18-3617.

### City Attorney

18-3622 Quasi Judicial (QJ) Proceedings

Ms. Fernandez commented on the quasi-judicial process by other municipalities.

Discussion followed on having a designated representative assigned to speak on behalf of a group, having a time limit for cross examination, redirect, having the city attorney sit next to the mayor during quasi-judicial proceedings, attorney acting as a fact witness, and incorporting items into the ordinance.

Ms. Fernandez noted an affected party status form is being drafted.

Jeff Boone, Boone Law Firm, spoke to his experience with quasi-judicial hearings, limiting audience participation to three minutes, lining up five speakers at a time, civility code, affected party status, attorney acting as a fact witness, and restricting cross examination of attorneys.

Discussion continued on three minute time limit for audience participation, civility code, city residents, cross examination of attorneys, cross examination being questions only, lining up four to five speakers at a time, limiting cross examination timeframe, and Ms. Fernandez providing council with a proposed draft.

Mr. Lavallee spoke to providing council with a list of different mechanisms used to obtain request for information at the next council meeting.

Ms. Stelzer suggested Mr. Lavallee provide an update at the December 11, 2018 council meeting.

Ms. Fernandez noted meeting with Fire Chief Shawn Carvey and Fire

Marshall Jack Stevenson regarding the county's code on open burning, and stated she will bring forth an ordinance at the next meeting suggesting the city require air curtain incinerators for burning land clearing debris.

## Council Member Fiedler

Ms. Fiedler reported on the EAB meeting, Lock it or Leave it Gun Program, and Sarasota Memorial Hospital meeting and the Elks Club.
