Sarasota Water Treatment Facility fieldtrip, school garden, donated rain barrel, school drains, garden club, water consumption, recycling program, Sea Camp, Save the Straw, biodegradables, reusables, marine debris, algae bloom, food containers, public awareness, compost, and answered board guestions on fresh and salt water studies and effects.

Gage Hassler, Epiphany Cathedral School Environmental Club, answered board question on what he would do if he was governor.

Ms. Richardson answered board questions on Red Tide and ideas.

Mayor Holic spoke on state legislative session, preemption ordinances, banning straws and plastic bags, and biodegradables.

Board discussion continued on Tampa Bay Times article, effects of plastic utensils, banned plastic straws, preemptions, plastic versus paper bags, and resources.
