Discussion followed regarding hiring city staff versus contracting outside services, conducting a full synopsis of the entire downtown road project for citizens, fact sheets, and project management system.

#### V. PUBLIC HEARINGS

#### A. ORDINANCES - FIRST READING

# ORD. NO. 2019-11

An Ordinance Amending the Official Zoning Atlas of the City of Venice, Florida, for the Property Located at 116 North Tamiami Trail and Owned by Venice Palm, Inc., Pursuant to Rezone Petition No. 18-02RZ, From Commercial, Business District (CBD) and Venetian Theme (VT) Architectural Control District to Commercial, General (CG) and Venetian Theme (VT) Architectural Control District; Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date (Quasi-Judicial)

Vice Mayor Cautero announced this is a quasi-judicial hearing.

Ms. Stelzer read the ordinance by title only.

Vice Mayor Cautero opened the public hearing.

Ms. Fernandez queried council on conflicts of interest and ex-parte communications. Mr. Newsom disclosed attending the planning commission meeting and site visit, Mr. Daniels disclosed getting gas at the site, and Ms. Moore disclosed viewing presentation at the Architectural Review Board (ARB) meeting. There were no conflicts of interest.

No written communication was received.

Council waived staff's presentation.

Mr. Clark, being duly sworn, responded to council questions regarding the automotive shop behind the 7-11, site and development plan, landscaping to include Florida Friendly Yards, special exception, canopy, and turn lanes.

Jeffery Boone, representing the applicant, being duly sworn, spoke to evidence in the record supporting rezone, planning commission's approval of the site and development plan contingent upon approval of the rezone, special exception for outdoor storage, ARB's approval of the project design, gas station, improving the site, gas stations on the island, site and development plan, access points, Commercial, General (CG) zoning to allow conforming use, architectural renderings, Florida Friendly Yards landscaping, and code compliant landscaping approved by the planning commission.

Discussion followed regarding Florida Friendly Yards landscaping initiative, outdoor bathrooms, volunteers to maintain landscaping, Venice Avenue gateway, not requiring applicant to return to the planning commission for approval of a different landscape plan, driveways, canopy, and access points.

Andrew Newman, Batesforum Architects, being duly sworn, spoke to the gas station canopy and responded to council questions regarding canopy dimensions.

Discussion continued regarding Florida Friendly Yards landscaping, not requiring the applicant to return to the planning commission for approval, and zoning change process.

Ms. Fernandez spoke regarding zoning changes and development approvals, and recommended not to change the process.

Discussion ensued on applicant's request, nonconforming protection, improving the site, and Florida Friendly Yards landscaping.

No one signed up to speak.

Mr. Shrum, being duly sworn, commented on the landscaping and rezoning request.

Vice Mayor Cautero closed the public hearing.

A motion was made by Council Member Newsom, seconded by Council Member Fiedler, to approve Ordinance No. 2019-11 on first reading and schedule for final reading. The motion carried by the following vote:
