Consider and Act Upon Preliminary Plat Petition No. 18-06PP for Cassata Place Creating 28 Attached Single-Family Dwelling Units and Associated Infrastructure (Quasi-Judicial)

Mayor Holic announced this is a quasi-judicial procedure and opened the public hearing.

Ms. Fernandez queried council members on conflicts of interest and ex-parte communications. Mr. Newsom disclosed attending the planning commission meeting and site visit, Mr. Daniels disclosed a meet and greet with Auburn Woods homeowners association (HOA) but did not discuss subject application, and Ms. Moore and Mayor Holic disclosed site visits.

No written communication was received.

Mr. Anderson, being duly sworn, provided a presentation and spoke to project location, property history, project proposal to include elevations, land development regulations (LDRs), Venetian Gateway (VG) overlay, compatibility analysis, variances, comprehensive plan, review of concurrency and mobility, conclusions and findings of fact, planning commission's action, stipulation, and responded to council questions regarding Kunze Road.

Mr. Clark, being duly sworn, spoke to easement and property drainage.

Discussion followed on chipping, constructing a temporary fence along the property line, rezoning application, stipulation, compliance with LDRs, Auburn Woods HOA's request for a fence, berm, fence location, side setbacks and lot coverage, current zoning presented, proposed and

allowable dwelling units per acre, current density of Auburn Woods, variances to include proposed legislation, and adding a temporary buffer during construction.

Mr. Shrum, being duly sworn, clarified the code section for variances.

Discussion continued regarding fence, compliance with the zoning code, zoning application, fence height, and swale.

Jackson Boone, representing applicant, being duly sworn, spoke to fence request, temporary construction mitigation fence, density of Auburn Woods, lot setbacks consistent with Auburn Woods, and responded to council questions regarding fence height.

Ms. Fernandez responded to council questions regarding a temporary fence.

Mr. Boone responded to council questions regarding chipping, marking storm drains, and accommodating Auburn Woods HOA's requests on prohibiting shining lights into residents homes and removal of mature trees.

Jeffery Boone, Boone Law Firm, being duly sworn, commented on the zoning stipulation, temporary use fence permit, and responded to council questions regarding fence height.

Discussion continued on temporary use fence permit and setting a precedent.

Jackson Boone commented on the rezoning application, street lighting, and tree removal.

Discussion followed regarding variances.

Jackson Boone spoke to Code Section 86-230 regarding variances.

Jeff Boone commented on the application and modification request.

Discussion continued regarding LDRs, creating a buffer during development of the property, staff determining approval of a temporary construction fence, and developer working with the surrounding neighbors.

Jackson Boone requested council's approval of the preliminary plat petition.

Mr. Newsom spoke to observed parking availability in the downtown area, directional parking signs, and requested council direct staff to identify

locations for directional parking signs in the downtown business district.

Discussion followed regarding parking signage, free parking and charging stations, downtown parking, valet parking services, concern with number of signs, private parking lot on Miami Avenue, parking maps, available parking options, designating parking spots for golf carts and motorcycles, and driverless vehicles.

There was consensus to direct staff to identify locations for directional parking signs in the downtown business district.

Commissioner Hines spoke on the memorandum from Director of Emergency Services Rich Collins regarding a hurricane evacuation center to include Sarasota Memorial Hospital (SMH) evacuation center recommendation, building a multi-use facility, hardening Taylor Ranch School and convention center idea, water quality summit on June 5, 2019, addressing water quality, Dona Bay, Legacy Trail, Atlanta Braves Stadium opening, River Road project, homelessness, the county sheriff's homeless outreach team (HOT), providing temporary housing for the homeless, affordable housing, amending the code to allow accessory type buildings, and renovation of the south county courthouse.

Discussion followed regarding affordable housing to include the Sadowski trust fund and CDBG grants, city and county partnership, John Nolen's Plan, county funding for a hurricane shelter to include the county's plan to allocate funding on a recurring basis, hardening Taylor Ranch School, building a multi-use facility, corridor connecting Knights Trail to Clark Road, making State Road 681 a full north/south interstate interchange, and temporary facility for the homeless.

Mayor Holic suggested including protected shark species in the project.

Dennis King, President, Experimental Aircraft Association (EAA), spoke regarding EAA memberships, supporting aviation events and area youth, awarded scholarships, monthly Young Eagles rally, and student flights.

Kim Kindell, Director of Rotary Futures, VHS, commented on scholarships awarded to VHS students, the need for women in aviation, and partnership with VASI and EAA.

Discussion followed regarding student talent at VHS, Suncoast BBQ Bash scholarships for student volunteers, Young Eagle flights, Venice airport, and University of Florida's innovation station engineering program.

Southwest Florida Regional Planning Council Update

Ms. Fiedler reported on the Southwest Florida Regional Planning Council (SWFRPC) meeting.

Ms. Moore returned to the meeting at 3:10 p.m.

Ms. Fiedler spoke regarding the Charlotte Harbor National Estuary Program (CHNEP) and coastal advisory committee grants.

COUNCIL ACTION/DISCUSSION - Continued

19-3950 Report on Use of Magistrate for Construction Board of Adjustments and

Appeals (Fernandez)

Ms. Fernandez reported on use of magistrate for the construction board of adjustment and appeals (CBAA), explained alternative options, and noted she has not obtained the building official's opinion and does not recommend abolishing the board.

Discussion followed regarding having the board remain as is, the last time the CBAA met, maintaining local control, number of seats on the board, sending a letter to members confirming their willingness to serve on the board, board member requirements and specifics, filling board vacancies, and dissolving the board until needed.

Ms. Fernandez responded to council questions on required board member training.

Discussion ensued regarding maintaining local control, alternative for code enforcement board to handle citations related to unlicensed contracting and unpermitted work, and Mayor Holic reporting back to council once CBAA members respond on their continued willingness to serve on the board.

Direct Staff to Enter into Discussion with Sarasota County on Building a Dual Purpose Hurricane Shelter/Sports Complex Building in Wellfield Park or Other Appropriate Location (Holic)

Discussion took place regarding the police firing range, using park impact fees for a dual purpose shelter, temporary homeless shelter, sports complex, city allocating money towards a shelter, the Venice Community Center, SMH building hardening, recommended locations to include Wellfield Park and a parcel located at Honore Road and Laurel Road, Wellfield Park users, combining resources with the county and state, county initiatives on a hurricane shelter, and requesting the city manager contact the county administrator for regular updates.

Ms. Fiedler left the meeting at 3:44 p.m. and did not return.

Discussion continued on park impact fees, Wellfield and Chuck Reiter parks, dual purpose facility, county mandate to provide hurricane shelters, postponing item until county provides direction, using park impact fees on Wellfield Park, Taylor Ranch School to include funding to harden building, memorandum from Mr. Collins, and council obtaining updates on county initiatives on a regular basis.

Mr. Lavallee noted staff will request the county administrator to provide periodic updates on county initiatives.

Discussion followed regarding public records requests to the county.

Approval to Request the Florida Fish and Wildlife Conservation Commission and the Florida Department of Health to Make a Presentation on the Changes in the Law Regarding Shark Fishing (Holic)

Mayor Holic spoke to his request and new regulations going into effect July 1, 2019 by the Florida Fish and Wildlife Conservation Commission.

Discussion took place regarding enticing sharks where individuals are swimming and fishermen chumming the waters.

Mr. Lavallee noted he will assign staff to request a presentation and update on regulations.

A motion was made by Council Member Newsom, seconded by Council Member Moore, to extend the meeting time beyond 5:00 p.m. The motion carried by voice vote 4-2 with Mr. Daniels and Mayor Holic opposed.

Discussion continued on jurisdictions prohibiting shark fishing, the city attorney researching if there is a consitutional amendment on shark fishing, and previously recommended pier rules.

There was consensus for staff to request the Florida Fish and Wildlife Conservation Commission and the Florida Department of Health to make a presentation on the changes in law regarding shark fishing.

A motion was made by Council Member Daniels, seconded by Council Member Newsom, to direct staff to prepare the required ordinance to suspend the Parks and Recreation Advisory Board. The motion carried unanimously by voice vote.

Mayor Holic reported on breakfast with the mayor to include Venice MainStreet's suggestion for color changing LED lights in downtown, Environmental Advisory Board (EAB) meeting, Council of Governments (COG), and commented on Mr. Lavallee's letter to the county administrator regarding the city taking over emergency medical services (EMS).

Discussion followed regarding restaurants voluntarily abolishing plastic straws and EMS memo sent to the county administrator.
