	Ms. Senne provided a presentation on fiscal year (FY) 20 tourist, sales taxes, budgeting, and answered board ques of tourist and average projections.	
	Ms. Senne continued to speak on revenue fluctuations, expenses, fiscal year endings, roll-overs, purchase orders, encumbrance funds, expenses, timing of fiscal year end, spending expenses, previous revenue funds, 2019 adopted budget, amended budget, net revenues, outstanding purchase orders, council appropriated budget, original projects, budget	

workshops, budget public hearings, specific expenditures, expectations, final budget, variances, project overview, top 10 major projects list, infrastructure, public works projects, strategic plans, fleet replacement funds, capital budget, depreciation, capital items, general reserve fund, one-cent sales tax, future planning, bridge loan, debt service fund, tax bill, interlocal county funds, and target reserve funds.

Ms. Senne continued to speak on FY 2019 budget to include, revenue, expenditures, projections, fund balance, reserves, required reserves, summary of previous years, and answered board guestions on budget projections, staff department meetings, individual department expense budgets, budget enhancements, proposed budget, detail processes, city manager approval, amended budget, encumbrance budget, under budgets, conservative revenue budgets, negotiated contracts, capital expenditures, one-cent sales tax, citizen donations, general fund, interest, adjusted budgets, and 301 funds.

Mr. Welch spoke on expiration of sales tax funds, bridge loan, and answered board questions on interest, one-cent sales tax, larger projects, general fund, capital cost, fleet replacement program, county wide vote, revenue, objections, unfunded projects, major maintenance, and project studies.

Ms. Senne spoke on Venice Community Center, one-cent sales tax, increasing taxes, capital, general fund, and homesteading.

Discussion took place on maintenance, fleet, other projects, capital projects, enhancing projects, audits, one-cent sales tax, non-major funds, major funds, and unqualified opinions.

A motion was made by Ms. Silk, seconded by Mr. Williams, to approve the presented proposed project list. The motion carried unanimously by voice vote.
