Erin Silk, Chief Executive Officer, Venice MainStreet Inc.: Proposal for an Interactive Mural to be Painted in Historic Downtown Venice

Erin Silk, Venice MainStreet Inc., provided a presentation on proposed mural, photographs, 15 submissions, artist background, encouraging public pictures, stock image, advantage point, placement of dolphins, building shadow cast, Three Dimensional (3D) effect, and social media.

Ms. Trammell announced she serves on the Venice MainStreet committee, her involvement in earlier phase of project, no involvement with selection of the final three artists, and no financial benefit.

Ms. Silk answered board questions on types of dolphins on mural, 3D effect, realistic images, busy background, softer image, sun fade, airbrushing, spoke on social media feedback, airplane, font style, choosing a building, stock imagery, sealing, unpainted surface and stucco, open space, length of painted work area, framed pictures, postcard image, and image opportunities.


Board discussion took place on approved kaleidoscope, padded walkway, and kaleidoscope ceremony presentation.
