C. COUNCIL ACTION/DISCUSSION

20-4474 Response and Actions Related to COVID-19

Mr. Lavallee reported on Deputy Fire Chief Frank Giddens' communication with Sarasota County's Emergency Operations Center (EOC) and COVID-19 reports sent to staff on a daily basis, and responded to council questions regarding the city's budget projections.

Mr. Lavallee spoke on the city's initiative allowing food trucks licensed by the state to operate their businesses remotely, and responded to questions regarding protections surrounding food trucks and council obtaining hard data from the finance department on budget projections.

Ms. Stelzer noted finance staff will be presenting requested information at the next council meeting.

Discussion followed regarding the city's finances, developing contingencies based on revenue streams, and the the city's response to COVID-19.

Mayor Feinsod urged residents to wear a mask in public.

Chief Carvey reported on the department's SUV responding to calls along with the fire engine to minimize personnel exposure, Emergency Medical

	Mr. Lavallee explained the county approved the use of up to \$400,000 in city impact fees to pay for the preliminary engineering of the project with contingencies to include the city would be responsible for managing the project, and the city would have up to ten years to complete the construction or pay back the cost of the initial engineering work, and inquired if council wants the city to proceed with formulating a funding agreement with the county.	on
	Discussion took place regarding project management, engineering design timeframe, project funding, and process to solicit engineering firm.

Discussion followed on impact fee revenue from development, criteria for use of road and mobility impact fees, project funding sources, one-cent sales tax, Jacaranda Boulevard extension, April 28, 2020 virtual council meeting, the economy's financial recovery time, prioritizing critical needs for the city, and concern with the city entering a public/private partnership with Neal Communities.

Vice Mayor Newsom spoke to resident feedback received and noted residents are not in favor of spending discretionary money on road project at this time.

Discussion continued on postponing motion to a future meeting in council chambers.
