## **CALL TO ORDER**

Mayor Feinsod called the meeting to order at 9:02 a.m.

Ms. Fernandez referenced Executive Order No. 20-69 issued by Governor DeSantis and Executive Order No. 2020-04 issued by the city regarding public meetings, and commented on public participation in public meetings.

#### IV. NEW BUSINESS

## A. PRESENTATIONS

### 20-4609

Dr. Julio Gonzalez, Orthopaedic Center of Venice and Karen Fordham, CEO, Venice Regional Bayfront Health: Overview of COVID-19 in Venice (15 min.) (Neunder)

Dr. Julio Gonzalez, Orthopedic Center of Venice, provided a presentation and spoke to daily new cases, active cases and death rates in the United States and Florida, correlation between cases and testing, age groups, emergency room visits, hospital admissions, and causes of surge.

Karen Fordham, CEO, Venice Regional Bayfront Health, provided a presentation and spoke to medical staff and administration weekly meetings, changing policies and procedures, telehealth visits, technical innovation, Intensive Care Unit (ICU) rooms, volunteers and the community, supplies received from schools, statistics on increased cases, patients admitted with positive results, death rates, and safety measures.

Discussion followed regarding Dr. Gonzalez providing a copy of his presentation to council, statistics on tourists and seasonal residents, long term health effects of contracting COVID-19, recurrence, medical resources, and the increase in numbers and death rates.

#### B. COUNCIL ACTION/DISCUSSION

## <u>20-4610</u> Discuss Face Coverings (Cautero)

Ronald Musselman, 512 Valencia Road, provided a presentation and spoke on his scientific credentials, daily COVID-19 cases in Florida and Sarasota County, 1930's research on aerosols, six foot rule, airborne transmission, and masks to include performance.

Pamela Fiume, 604 Menendez Street, commented on wearing masks, social distancing, mask protection, and noted opposition to mandating masks.

Recess was taken at 10:06 a.m. until 10:16 a.m.

James Hoel, 242 Piazza Di Luna, spoke to statistics and studies on wearing masks, burden on employers and employees, and Occupational Safety and Health Administration (OSHA) regulations.

A motion was made by Council Member Cautero, seconded by Dr. Fiedler, to discuss face coverings.

Mr. Pachota called for a point of order and inquired if a motion was needed to discuss an item on the agenda.

Ms. Stelzer clarified a motion is not needed to discuss an item on the agenda. Mr. Cautero withdrew his motion and Dr. Fiedler withdrew her second to the motion.

Discussion followed regarding prior council action at the May 21, 2020 meeting on a mask ordinance, elevation in new cases and hospitalizations, Sarasota Memorial Hospital (SMH)'s community press release urging public officials to require masks be worn in public places, rate of positive testing, the city's distribution of masks, Longboat Key's mask ordinance, the city issuing a temporary mask ordinance, enforcement, constitutional rights, the county's support of a county-wide mandate, citizen confrontations, City of Sarasota's mask ordinance, private businesses, adopting a resolution to promote and encourage face masks and installing signs around the city, the city's boundary, citizen emails received, public discourse, focusing on the downtown area, signs for businesses requiring face masks to be worn, entity to enforce ordinance, liability concerns, burden on law enforcement, adopting an ordinance versus a resolution, residents feeling safe, and long term health effects of contracting COVID-19.

Per the mayor's request, Mr. Lavallee explained the difference of adopting an ordinance versus a resolution.

Mayor Feinsod read correspondence from Michael Klauber, Michael's on East, Sarasota, on mandatory mask requirement.

Discussion ensued on temporary ordinance, enforcement, and having a two prong approach by adopting a resolution first then an ordinance.

Ms. Fernandez spoke regarding an emergency ordinance, resolution encouraging mask wearing, enforceability, constitutionality, and responded to council questions on the number of readings required to adopt a resolution.

Mr. Lavallee noted state statute requires five affirmative votes to pass an

emergency ordinance.

Chief Mattmuller responded to council questions on enforcement and burden on law enforcement.

Ms. Fernandez commented on City of Sarasota and Longboat Key's civil citation process, and noted the city does not have a process to hear appeals for citations.

Discussion continued regarding civil citation process.

A motion was made by Council Member Cautero, seconded by Dr. Fiedler, to direct staff to draft a reasonable temporary mask ordinance for review at a special council meeting as soon as possible.

Discussion followed on having a two prong approach with a resolution first and then an ordinance.

The motion failed by the following vote:

Yes: 3 - Mayor Feinsod, Mr. Cautero and Dr. Fiedler

No: 4 - Vice Mayor Newsom, Ms. Moore, Mr. Pachota and Dr. Neunder

A motion was made by Council Member Pachota, seconded by Council Member Moore, for the city attorney to draft a resolution directing citizens to wear face masks in public.

Discussion followed on eluding to the Florida Surgeon General's public health advisory, referring to Sarasota County Board of County Commissioner's endorsement on face masks, and advocating the city's position.

The motion carried by the following vote:
