Ms. Gainfort reported that the total fund was \$39,466,635 as of 12-31-19 with a net rate of return of 6.9% for the quarter. Ms. Gainfort reviewed the individual manager performance; there may be a need for rebalancing. Ms. Gainfort reviewed the compliance checklist.
