Kara Morgan, Venice MainStreet (VMS), provided a presentation on a digital, interactive kiosk, requested support for installation and funding for placement in Centennial Park, spoke on expected benefits, staffed kiosk with volunteers, timeline, cost estimates, proposed partnership, and answered Council questions regarding the businesses requesting the kiosk, and business financial contributions.

Discussion took place regarding dues paid to VMS, City contributions to VMS, support of some Council Members, one time investment, helping entire downtown area, considering a 50% contribution, non-financial VMS contributions, raising private donor funds, City events, and marketing opportunities.

City Manager Lavallee commented on staff discussion with Ms. Morgan, the option to put project in the Capital Improvement Plan for FY 24, with the City to purchase and own, and to negotiate an agreement with VMS to manage it.

NO.An Ordinance of the City of Venice, Florida, Granting Zoning Map2023-11Amendment Petition No. 22-38RZ for the Milano Planned Unit<br/>Development (PUD) Located at Laurel Road and Jacaranda Boulevard, by<br/>Changing the Land Use Designation for an Approximately 10.42 Acres<br/>Parcel from Open Space to Commercial and Amending the Milano PUD<br/>Binding Master Plan (BMP) to Allow for Commercial Development;<br/>Providing for Repeal of all Ordinances in Conflict Herewith; Providing for<br/>Severability; and Providing an Effective Date (Quasi-judicial)

Clerk Michaels read the ordinance by title only.

Mayor Pachota opened the public hearing.

City Attorney confirmed with Mrs. Frank that she was able to review the video from the final day of the first reading of the ordinance on June 16, 2023.

City Attorney Fernandez questioned Council Members concerning ex-parte communications and conflicts of interest since the hearing on June 16, 2023. Dr. Fiedler stated she had individuals attempt to speak to her regarding the ordinance, and informed them she could not discuss, and she also turned in written correspondence to the Clerk. Mr. Longo disclosed attempts of individuals to speak to him, and a site visit.

City Attorney Fernandez reviewed the procedures for the quasi-judicial hearing, not designed to redo anything from the first hearing, conclusory remarks, whether there is competent substantial evidence in the record, popularity of the application should not be considered, requests for additional time do not need to be acted on. She highlighted items changed on the ordinance, Section Three stipulations added the applicant referenced at the first hearing: 1) The total commercial square footage to be limited to 70,240 and 2) The buffer modification request to be withdrawn. Both items have been incorporated into the Milano PUD Binding Master Plan Amendment dated July 3, 2023, and are attached to the ordinance.

Communications were provided ongoing, in advance, and are part of the record.

Debbie Gericke, 146 Bella Vista Terrace 14C, being duly sworn, spoke

against the Zoning Map Amendment Petition.

Anthony Demeo, 249 Mestre Place, being duly sworn, expressed agreement with Debbie Gericke.

Pat Appolonia, 157 Padova Way, being duly sworn, expressed agreement with Debbie Gericke.

Nancy DeForge, 332 Laurel Hollow Drive, being duly sworn, spoke against the Zoning Map Amendment.

Tyler Cassell, 201 Medici Terrace, being duly sworn, spoke against the Zoning Map Amendment.

Jill Pozarek, representing affected party North Venice Neighborhood Alliance, being duly sworn, spoke against the Zoning Map Amendment, encouraged the City to get open space dedicated, traffic in the City, and following laws.

Marshall Happer, on behalf of affected party Venetian Golf and River Club (VGRC), being duly sworn, spoke regarding Council's decision, commercial uses, and proposed stipulations.

Gary Scott, affected party, being duly sworn, spoke against the Zoning Map Amendment, Council's decision, compatibility, definition of open space, restrictions, and lack of compliance with comprehensive plan.

Jeffery Boone, agent for applicant, being duly sworn, spoke regarding the affected party's proposed ordinance, conclusions, findings of fact, against the affected party's requested stipulations, Council followed the law, unified control, and substantial evidence to approve the petition.

Discussion took place regarding listening to all the evidence, proposed stipulations, information provided, following laws, stating reasons for denial of petitions, not for approval of petitions, competent substantial testimony, zoning map amendment petition only, expert testimony, traffic studies and analysis, compatibility, comments from the public towards Council, 86-130(r), needs of the Planned Unit Development (PUD), and Council determining code language concerns.

A motion was made by Mr. Longo, seconded by Vice Mayor Boldt, that based on review of the applicant materials, the staff report and testimony and evidence provided during the public hearings, Ordinance No. 2023-11 be approved and adopted as presented. The motion carried by the following electronic vote:

Discussion took place regarding appealing the attendance policy, being held accountable by the voters, and if Council wanted to eliminate the policy it would need to be voted on by the citizens.

Discussion continued regarding the expense of a charter amendment, expanding the reasons for excuse, opposition of amending the charter, time and expense, personal travel, employment obligations, not being afraid of charter amendments, dedication, virtual attendance, quorum concerns, public record, and continuance of regular public meetings.

Discussion ensured on clarifying virtual attendance option when needed, Council not needing to vote for approval, and if the option is abused Council could revoke.

City Attorney Fernandez will revise resolution to clarify.

There was consensus to proceed with the meeting attendance policy as presented by the City Attorney, specifying if the City Clerk receives one of the seven named reasons for absence, Council Member is excused without a vote, and a generic category description of absence is recorded in the minutes. A Council Member may request Council to consider and vote to excuse on the reason for absence if it is outside of the seven named categories. When a regular meeting is carried over and extends into additional days, a member is not considered absent for the subsequent meeting day(s), as it pertains to Section 3.07(b) of the Charter.
